RESOLUTION RECOMMENDING TO DECLARE XD EVER TRANSFORMER SERVICE CORPORATION AS THE SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING AWARD OF CONTRACT.

WHEREAS, Annual Procurement Plan of San Francisco Water District includes the **PROCUREMENT OF 15mm and 20mm CLASS B MULTI-JET ANTI MAGNETIC WATER METER PN 10;**

WHEREAS, Purchase Request No. 2023-12-0334 dated on December 26, 2023 was requested by the SFWD Administrative Section to purchase 1,570 pieces of 15mm and 120 pieces of 20mm Class B Multi-Jet Anti-Magnetic Water Meters intended for new service connection, change meter and calibration which amounted to **Php 3,636,600.00;**

WHEREAS, **BAC RESOLUTION No. 2023-12-286** dated on December 29, 2023 recommends the use of **COMPETITIVE BIDDING** as the mode of procurement;

WHEREAS, on December 29, 2023 a Pre-procurement plan was conducted by the BAC members with the Technical Working Group to standardized all legal, technical, and financial documents to be stipulated in the Bidding Documents;

WHEREAS, the advertising and contents of the invitation to Bid/Request for expression of interest was posted by the BAC Secretariat on PHILGEPS OFFICIAL WEBSITE and conspicuous places of SFWD dated from **January 04, 2024 to January 10, 2024;**

WHEREAS, a Pre-bidding conference was conducted on January 11, 2024 which was attended by two suppliers namely **XD EVER TRANSFORMER SERVICE CORPORATION and AMK CORPORATION;**

WHEREAS, **SUPPLEMENTAL/BID BULLETIN NO. 1** was posted on PHILGEPS official website on **January 17, 2024;**

WHEREAS, in response to the posted invitation, only **XD EVER TRANSFORMER SERVICE CORPORATION** purchased the Bidding Documents;

WHEREAS, on **January 24, 2024**, the BAC conducted **Preliminary Evaluation/ Opening of Bids** and through a detailed evaluation to the **LEGAL, TECHNICAL and FINANCIAL DOCUMENTS** submitted by XD EVER TRANSFORMER SERVICE CORPORATION it was found to be **COMPLETE/PASSED** all of the requirements which was stipulated in the Bidding Documents;

WHEREAS, **BAC RESOLUTION No. 2024-01-029** dated on January 25, 2024 resolution declaring XD EVER TRANSFORMER SERVICE CORPORATION as the **SINGLE CALCULATED BID (SCB);**

WHEREAS, on January 25, 2024 a notice of **SINGLE CALCULATED BID (SCB)** was released and sent through e-mail to XD EVER TRANSFORMER SERVICE CORPORATION;

WHEREAS, Pursuant to RA 9184 of Revised Implementing Rules and Regulation section 34.3, the BAC and the Technical Working Group had conducted a post qualification process from January 25, 2024 to February 05, 2024 in order to verify and validate the compliance and responsiveness of the submitted bid by XD EVER TRANSFORMER SERVICE CORPORATION to all of the requirements and conditions specified in the Bidding Documents;

WHEREAS, On February 5, 2024, the results of the post-qualification process were decided upon using a non-discretionary criterion. Hereunder are the results:






