## "KOLEHIYO MO, SAGOT NG SFWD SCHOLARSHIP PROGRAM"

SFWD Board Res. No. 8, s. 2013

### **ELIGIBILITY CRITERIA:**

The SFWD College Scholarship will be awarded to the qualified or graduate senior high school students. All applicants **MUST** meet the following eligibility criteria:

1. Applicant must be a Grade 12 student upon application or had finished Grade 12 in the previous school year.
2. Applicant must have a Grade Point Average (GPA) of 85% and above without below 80% grade in all subjects in Grade 12.
3. Applicant must submit Income Tax Return (ITR) 1701 of the parents from the previous year as annual income or Certificate of Tax Exemption from the Bureau of Internal Revenue (BIR).
4. The parent/s of the applicant must be Filipino citizen/s and resident of San Francisco, Agusan del Sur for at least one (1) year from the time of the application.
5. Must have completed the secondary education in any high school in San Francisco or Prosperidad, Agusan del Sur;
6. Applicant must **pass any State Universities and Colleges Entrance Examinations**;
7. **Applicant must not be a family relative of any SFWD employee** and the current panel of the Board of Directors up to the 4<sup>th</sup> degree of Affinity and Consanguinity.

### **INCENTIVES:**

1. Monthly stipend of PhP 8,000.00 (for scholars studying outside Caraga region) or PhP 6,000.00 (within Caraga region)
2. Book allowance of PhP 10,000.00 per school year
3. FREE Tuition and miscellaneous fees
4. FREE Traveling allowance
5. Uniform allowance of PhP 2,500.00 per school year

### **Requirements for Application:**

1. Application Letter for SFWD Scholarship Program (2 copies)
2. Filled out Application Form (forms c/o SFWD)
3. Certification from the Principal with Form 137
4. Authenticated Photocopy of Income Tax Return (ITR) 1701 of the parents from the previous year **or** Certificate of Tax Exemption from the BIR
5. Barangay Certificate of Residency
6. Photocopy of College Entrance Exam Result from Public Colleges/Universities (if available)
