RESOLUTION DECLARING TOYOTA TAGUM CITY AS THE LOWEST CALCULATED AND RESPONSIVE BID (LCRB) AND RECOMMENDING THE SAME FOR AWARD OF CONTRACT.

- WHEREAS, Annual Procurement Plan of San Francisco Water District includes the PROCUREMENT OF One (1) Unit Brand New 4x2 Passenger Van:
- WHEREAS, Purchase Request No. 2023-12-0327 dated on December 07, 2023 was requested by the SFWD Management Section to purchase One (1) Unit Brand New4x2 Passenger Van for general urban use which amounted to Php.
- WHEREAS, BAC RESOLUTION No. 2024-01-005 dated on January 09, 2024 recommends the use of COMPETITIVE BIDDING as the mode of procurement;
- WHEREAS, on January 09, 2024 a Pre-procurement conference was conducted by the BAC together with the Technical Working Group to standardized all legal, technical, and financial documents to be stipulated in the Bidding Documents;
- WHEREAS, the advertising and contents of the invitation to Bid/Request for expression of interest was posted by the BAC Secretariat on PHILGEP's website, SFWD's OFFICIAL WEBSITE and conspicuous places at SFWD's building dated from January 19, 2024 until the closing period on February 08, 2024;
- WHEREAS, on January 26 ,2024 the SFWD Bids and Awards Committee had conducted a Pre-bidding conference which was attended only by IOYOIA IAGUM CITY's representatives;
- WHEREAS, SUPPLEMENTAL/BID BULLETIN NO. 1 was posted on PHILGEPS official website on February 01, 2024;
- WHEREAS, in response to the posted invitation, two suppliers purchased the Bidding Documents namely TOYOTA BUTUAN CITY AND TOYOTA TAGUM CITY;
- WHEREAS, two bidders namely IOYOIA BUIUAN CITY and IOYOIA IAGUM CITY had submitted their bids before the scheduled deadline of submission;
- WHEREAS, on February 08, 2024, the Bids and Awards Committee together with the Technical Working Group conducted a Preliminary Examination of Bids. The Bids and Awards committee examine the LEGAL, TECHNICAL, and FINANCIAL DOCUMENTS of two prospective Bidders. The Bids and Awards Committee declared that the two prospective bidders had PASSED to the Required Eligibility.
- WHEREAS, after the preliminary examination of Bids, it was declared that TOYOTA BUTUAN CITY was the LOWEST CALCULATED
- WHEREAS, on February 12, 2024 a notice of LOWEST CALCULATED BID (LCB) was released and sent through e-mail to TOYOTA BUTUAN CITY;
- WHEREAS, Pursuant to implementing rules and regulation of RA 9184 section 34.3, the BAC and the Technical Working Group had conducted a post qualification process from February 08,2024 to February 20, 2024 in order to verify and validate the compliance and responsiveness of the submitted bid by TOYOTA BUTUAN CITY to all of the requirements and conditions specified in the Bidding Documents;
- WHEREAS, on February 20, 2024, the results of the post-qualification process were decided upon using a non-discretionary criterion.
- WHEREAS, BAC RES No. 2024-02-048 dated on February 20,2024 recommends to declare the post-disqualification of TOYOTA BUTUAN CITY and to proceed for the post-qualification of the bidder who posted with the next lowest calculated bid namely TOYOTA TAGUM CITY;
- WHEREAS, on February 21,2024 a letter of post-disqualification was released and sent to TOYOTA BUTUAN CITY;
- WHEREAS, on February 23,2024 the BAC received a letter for reconsideration from TOYOTA BUTUAN CITY;
- WHEREAS, BAC Res No. 2024-02-53A dated on February 26, 2024 to REJECTED and DENIED the submitted motion for reconsideration by TOYOTA BUTUAN CITY;
- WHEREAS, Pursuant with Section 34.6, Rule X of the 2016 Revised and Implementing Rules and Regulation of RA 9184 the second-lowest bid was subject for post-qualification namely TOYOTA TAGUM CITY;

WHEREAS, on February 28, 2024 a notice of SECOND LOWEST CALCULATED BID (SLCB) was released and sent through e-mail to TOYOTA TAGUM CITY;

WHEREAS, on February 29, 2024 TOYOTA TAGUM CITY submitted a scanned copy of certificate of distributorship signed by the sales distribution vice president from TOYOTA head office;

WHEREAS, the Bids and Awards Committee together with the Technical Working Group had conducted a post qualification process for the submitted bid by TOYOTA TAGUM CITY from February 26,2024 to March 07, 2024;

WHEREAS, on March 07, 2024, the results of the post-qualification process were decided upon using a nondiscretionary criterion. Hereunder are the results:
