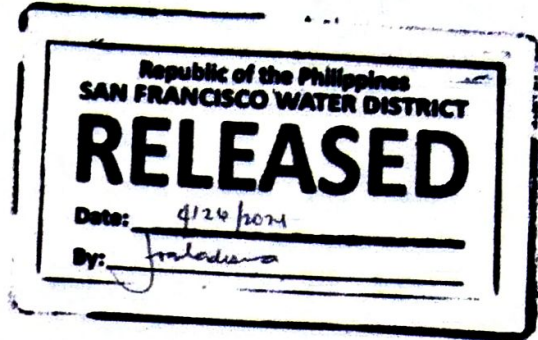



WHEREAS, **Purchase Request No. 2023-12-0328** dated **November 29, 2023**, was requested by the **ADMIN SECTION** to safeguard and protect the assets and properties of the district which amounted to **Php 6,127,200.00**;

WHEREAS, **BAC Res. Number 2024-02-047** dated **February 20, 2024**, a resolution recommending the use of competitive bidding as the mode of procurement;

WHEREAS, the BAC Secretariat posted an Invitation to Bid for the delivery of Twenty-three (23) Personnel for Security Services in the conspicuous places of San Francisco Water District and through the Electronic Catalogue of the Philippine Government Electronic Procurement System (PHILGEPS) dated February 27, 2024;

WHEREAS, in response to the said invitation, two (2) suppliers namely PhilGuard Security Services, Inc., and VISA Security Services purchased the Bidding Documents;

WHEREAS, the Opening and evaluation of Bids was conducted using pass/fail non-discretionary criterion. Hereunder are the results:
