WHEREAS, Annual Procurement Plan of San Francisco Water District includes Twenty-Three (23) Personnel for Security Services;	
WHEREAS, <u>Purchase Request No. 2025-02-0073</u> dated <u>February 20, 2025</u> was requested by the <u>Administrative Division</u> for the Procurement of twenty-three (23) personnel for security services which amounted to <u>Php.6,193,440.00</u> ;	
WHEREAS, Section 10 Rule IV of the Revised IRR of R.A 9184 states the all procurement shall be done through competitive bidding, except as provided in RULE XVI of this IRR;	
WHEREAS, Rule XVI of the IRR enumerated the Various Alternative Modes of Procurement which shall be used for purchases of goods and services exceeding One Million Pesos (1,000,000.00);	
WHEREAS, Section 5, h of Rule I of the IRR defines Competitive Bidding as a method of procurement which is open to participation by any interested party and which consists of the following processes: advertisement, pre-bid conference, eligibility screening of prospective bidders, receipt, and opening of bids, evaluation of bids post-qualification, and award of contract;	
WHEREAS, with the above-mentioned provision, the members of the Bids and Awards Committee (BAC) hereby recommended the use of COMPETITIVE BIDDING;	
NOW THEREFORE, upon motion of Mr. John Edward Licong, unanimously seconded, the BAC hereby –	
RESOLVED, as it is hereby resolved, to recommend the use of COMPETITIVE BIDDING as the mode of procurement;
