INVITATION TO BID FOR THE PROCUREMENT OF PORTABLE/MOBILE AIR COMPRESSOR

The San Francisco Water District, through the Approved Corporate Budget for the year 2025 as per Board Resolution No. 17 Series of 2025 intends to apply the sum of One Million Six Hundred Thousand Pesos (Php. 1,600,000.00) being the ABC to payments under the contract for the Procurement of Portable/Mobile Air Compressor. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The *San Francisco Water District* now invites bids for the above Procurement Project. Hereunder are the delivery schedule of the water meter:

Bidders should have completed, within the period *January 2023 - December 2024*, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino Citizens/sole proprietorships, partnerships, or organizations with at least sixty percent 60% interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the law or Regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183

Prospective Bidders may obtain further information from *San Francisco Water District* and inspect the Bidding Documents at the address given during 8:00am to 5:00pm. A complete set of Bidding Documents may be acquired by interested Bidders on *April 4*, 2025, from 8:00 am to 5:00 pm from the given address and website below and upon payment of the applicable fee for the Bidding Documents, according to the latest Guidelines issued by the GPPB, for *Five Thousand Pesos (Php. 5,000.00)*. The Procuring Entity shall allow the bidder to present its proof of payment for the fees. Bids will be opened in the presence of Bidder's representatives who choose to attend face-to-face.

The San Francisco Water District will hold a Pre-Bid Conference on April 11, 2025 at 2:00 P.M. in the SFWD Conference Room, SFWD Building, Osmeña Street, Brgy. 2, San Francisco, Agusan del Sur which shall be open to prospective bidders.

Bids must be duly received by the BAC Secretariat through manual submission of hard copies at the office address indicated below on or before *April 25*, 2025, at 2:00 P.M. Late bids shall not be accepted.





All Bids must be accompanied by a bid security in any of the acceptable forms and the amount stated in **ITB Clause 14**.

Bid opening shall be on April 25, 2025, at 2:00 P.M. at SFWD Conference Room, SFWD Building, Osmeña Street, Barangay. 2, San Francisco, Agusan del Sur.

The *San Francisco Water District* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award per Sections 35.5 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
